NantPharma has made the strategic decision to consolidate its manufacturing operations and is offering its Elk Grove Village, Illinois, cGMP Active Pharmaceutical Ingredients (API) manufacturing facility for sale. This 60,000 SF facility is located near Chicago's O'Hare International Airport and includes commercial and pilot scale capacity. PharmaBioSource Realty, LLC, has been exclusively retained by NantPharma to market the facility.



Highlights of the Facilities Include:

14,000 SF flexible, modern and isolated explosion proof API manufacturing suite:

- *Never used full-scale train capable of processing 2 X 3,600L per batch.*
- *Flammable solvent rated centrifuge and two large Millipore Ultra filtration skids.*
- *cGMP solvent evaporation unit and large spray dryer with multiple nozzle types.*
- *Five 6,000 gallon and two 3,000 gallon, stainless steel solvent storage tanks isolated in an explosion proof room.*
- *An additional 5,000 SF of shell space available for expansion of the manufacturing area.*

4,500 SF dedicated pilot scale API suite capable of processing 1 X 220L per batch:

- *Glass lined reactors, stainless steel tanks in an explosion proof room designed for large volume solvent use.*
- *Pilot scale centrifuge, filtration skids, solvent evaporation unit and spray dryer.*

Laboratory, office, warehouse and support facilities:

- *New 1,900 SF laboratory, a 5,600 SF warehouse and 5,500 SF of office space.*
- *Dedicated solvent delivery, transfer area and waste dock.*
